At the same time, 2 new priorities for the Development Strategy, with the aim of continuing development changes in a new historical phase it's joining. One is related to the maintenance of spiritual development, while the other is determined by Uzbekistan's attitude toward global problems that are taking place in the world is the priority direction of the yang i.

Thus, new Uzbekistan's development strategy for 2022–2026 outlines the following seven priorities:

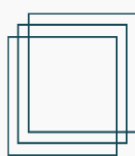
The first priority is the establishment of a patriotic state through the promotion of human values and the further development of a free civil society;

The second priority is to transform the principles of justice and the rule of law into the most fundamental and necessary prerequisite for development in our country;

The third priority is the development of the national economy, ensuring its growth rate at the level of time requirements;

The fourth priority is to pursue a fair social policy, develop human capital;

The fifth priority is to ensure spiritual development, fundamentally reform this sphere, and take it to a new phase;



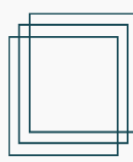
The sixth priority is to find solutions to human problems based on national interests; The seventh priority is to strengthen the security and defense capabilities of our country, to pursue an open and pragmatic, active foreign policy.

Second factor: It is not easy for the New Uzbekistan Development Strategy to advance the principle of "Action Strategy –Development Strategy". Because, first of all, the development of each direction of the Action Strategy on a logical and consistent basis in a new phase of development and the important results in new priorities to achieve. Human value is the chief principle. The main focus in development strategy is on the adoption of laws, codes, concepts and programs for the development of civil society. On the other hand, it includes ensuring the rule of law, implementing constitutional reform, improving the national economy, and implementing strong social policies. The development of material goods, as well as the relationship between Uzbekistan and global problems, encompasses important tasks related to security and foreign policy. Most importantly, the main idea of seven priorities in the New Uzbekistan development strategy is to ensure human value. Because the main idea in our President's electoral program was also the principle of "For Human Value." Factor three: at the level of national, regional and international cooperation in all aspects of our lives through legal and organizational and legal means how to do it? In development strategy, there are many practical answers to this pressing question aimed at many specific goals. So far, 26 concepts and a number of programs have been adopted in each priority of the Action Strategy, while in the future there are 13 codes and 12 as part of the Development Strategy the law, i.e. the adoption of the necessary legal acts in each priority direction. For example, the development of the Code of Criminal Procedure becomes a strong legal basis for the development of entrepreneurship in our country and the full protection of the rights of businesspeople. The code of criminal procedures on the future nonprofit organizations outlines the legal criteria of civil society. The Information Code – more than a dozen laws devoted to the media, journalists' activities, freedom of information and speech that have been enforced so far have been encoded will be the result of adoption as a unified and holistic law. Fourth factor: Not only is the name of the new U.S. balance strategy, but at the same time the priorities and important tasks set out in it harmonious and cohesive with international documents of great global importance, not just on a regional scale. A development strategy is fully consistent with the trends of world development. The United Nations has announced the Barqaror Development Goals in 2015-2030.

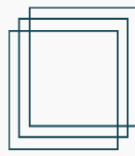
to Benefit Kingdom Service Worldwide has been prepared. specific tactics and strategies are being identified.

Improving the mechanisms for open communication with the public, expanding the practice of making important decisions in recognition of public opinion, and appeals to government agencies It is intended to digitize the process of consideration, ensure that applications are reviewed quickly and efficiently. Most importantly, the national program "People's Horse" is being developed, which aims to implement the idea of "The state must serve the people." In turn, section 46 of the "Yellow Map" discusses improving preventive mechanisms for the prevention of torture. The National Center for Human Rights is one of the main performers of this task. First, it is forbidden to consider the ratification of relevant international documents for the prevention of torture. Second, it will be necessary to develop the legal basis for a preventive national mechanism for the prevention of torture.
