The old lady whirled round, and snatched her skirts out of danger. The lad fled on the instant, scrambled up the high board–fence, and disappeared over it.

His aunt Polly stood surprised a moment, and then broke into a gentle laugh.[3:7] However, aunt Polly was too strict towards Tom, her love is noticable throughout the reading. Although Tom is a mischievous child, the author describes his purity of heart and childish innocence in the novel.

Character analysis of the novel "The Adventures of Tom Sawyer"

Tom is a character of unflagging energy and a real zeal for trickery. When the novel begins, Tom is a mischievous child who envies Huck Finn's lazy lifestyle and freedom. As Tom's adventures proceed, however, critical moments show Tom moving away from his childhood concerns and making mature, responsible decisions. This is noticable from the first chapter:

"Within two minutes, or even less, he had forgotten all his troubles. Not because his troubles were one whit less heavy and bitter to him than a man's are to a man, but because a new and powerful interest bore them down and drove them out of his mind for the time—just as men's misfortunes are forgotten in the excitement of new enterprises. This new interest was a valued novelty in whistling, which he had just acquired from a negro, and he was suffering to practise it undisturbed. He felt much as an astronomer feels who has discovered a new planet—no doubt, as far as strong, deep, unalloyed pleasure is concerned, the advantage was with the boy, not the astronomer."[3:5]

As Tom's adventures proceed, however, critical moments show Tom moving away from his childhood concerns and making mature, responsible decisions.[4:17]

Psychoanalytic approach in the novel

The novel projects a society disturbed with moral anarchy and the breakdown of the legal system. It is a world in which crimes, lawlessness and violence are omnipresent. The novel remain an eternal favourite as it appeals to both the children and the adults for the adventures that are intriguing and delightful and they appeal to the basic instincts of all regardless of time and culture. The plot of the novel narrates the growth and maturation of Tom; but what is most striking is that behind the narrative of Tom Sawyer, Twain speaks his own life-story. So Twain's Tom Sawyer should not merely be considered as a adventure story; it is rather a truthful account of the history of the contemporary American.
